

 - AI
 - Content Moderation
 - Digital Financial Technology
 - Deregulation
 - Technology Investment
- Revoked tech-related EOs from the Biden Administration

EO 14219 Ensuring Lawful Governance and Implementing the President's "Department of Government Efficiency" Deregulatory Initiative



EO 14219:

• (Alleged) Purposes:

- Reducing federal regulations Limits enforcement of certain rules to ease regulatory burdens and curb federal overreach.
- Restricting federal enforcement Constrains the executive branch's role in enforcing regulations to reinforce constitutional separation of powers.
- Prioritizing "economic and innovation-friendly" policies Directs regulatory efforts toward fostering economic growth and technological advancement through deregulation.

Exemptions:

• National security, military, homeland security, foreign affairs, or immigration policies.

• Implementation:

- Department of Government Efficiency (DOGE) Oversees execution of the President's DOGE Agenda; temporary organization; DOGE Teams in Regulatory Agencies
- Modernization Projects Example: Software Modernization Initiative.
- New Regulation Standards: EO 12866 (1993), consultation with DOGE Teams, deregulatory goals.
- Reviewing and Rescinding Regulations: constitutional authority, economic impact, and alignment with administration priorities.
